



Government Information (Public Access) Act Annual Report 1 July 2013 – 30 June 2014

Under the *Government Information (Public Access) Act 2009* (GIPA Act), there is a presumption in favour of the disclosure of Government information unless there is an overriding public interest against disclosure.

1. Review of proactive release program - Clause 7(a)

Nepean Blue Mountains Local Health District undertakes reviews of its information on a regular basis, including information requested via informal access and formal access channels. Liaison also occurs with Executive Directorates and their respective portfolios regarding identification of information that can be released proactively. Review of the Nepean Blue Mountains Local Health District disclosure log and websites of other agencies to see the type of information they release proactively, is also undertaken.

The most accessible way for the public to access such information is via the Nepean Blue Mountains Local Health District internet website, and this website is continually developed to make information readily available to the public. During 2013-14 the following information has been released proactively on the website:

- NBMLHD Board information including board member details, Board sub-committees and Board minutes
- NBMLHD Service Agreement 2013-14
- Strategic plans and reports
- Hospital and Community Health Centre parking and transport information, disability and access information, services provided and key news items
- Public health services including immunisation and environmental health
- Employment and career information and positions being recruited to
- Media releases, news stories, videos and NBM News
- Topical news items for the public

2. Number of access applications received - Clause 7(b)

During 2013-14, Nepean Blue Mountains Local Health District received four new formal access applications under the *GIPA Act*. Seven applications were decided, including three applications carried forward from 2012-13. No applications received during the reporting period were undecided as at 30 June 2014.

3. Number of refused applications for Schedule 1 information - Clause 7(c)

During the reporting period, Nepean Blue Mountains Local Health District refused part of one formal access application because the information requested was information referred to in Schedule 1 to the *GIPA Act* (information for which there is a conclusive presumption of overriding public interest against disclosure).

4. Statistical information about access applications - Clause 7(d) and Schedule 2

The following tables (A-H) outline statistical information about access applications – Clause 7(d) and Schedule 2.

In summary, of the seven access applications decided in 2013-14, seven decisions were made to grant access to the information in full, five decisions were made to grant access to the information in part, and two decisions were made to refuse access in full. Two decisions were made where the information was already available.
